Since this is a three day, State Board of Accounts called meeting, the law allows for your expenses even if you are a county in close proximity to the hotel. Your county policy only applies if it is a one day conference and not called by the State Board of Accounts. Per IC 5-11-14.1 ...(g) each official representing a unit and attending any conference under this section shall be allowed the following: Mileage – County Rate, Lodging, and meals to be paid from Unappropriated General Fund.. Since our registration covers meals directly connected to conference, your registration may be paid through these means. (j) A claim for reimbursement under this section may not be denied by the body responsible for the approval of claims if the claim complies with IC 5-11-10-1.6. Please see IC 5-11-14-1 for entire section of code.

State Board of Accounts will issue a proof of attendance to each Treasurer after the completion of the conference and tabulation of the attendance record.
